

# SECRETARY OF STATE LINKS

Secretary of State links below can be used to find Certificates of Good Standings.

Search an Entity by its name and follow prompts available to get the certificate.

You are allowed to grab short-forms as long as it has some mention of: *Active Status* for an entity or words such as *“hasn’t filed for dissolution”*

Some states, this status is not available, and you have to buy the actual Certificate. I have marked those with an x.

**Please Note: We ALWAYS require an actual certificate as opposed to snippets from these websites, but if a broker/borrower has one last thing left which is a Cert of Good Standing, this will work but please try to get the actual cert first.**
