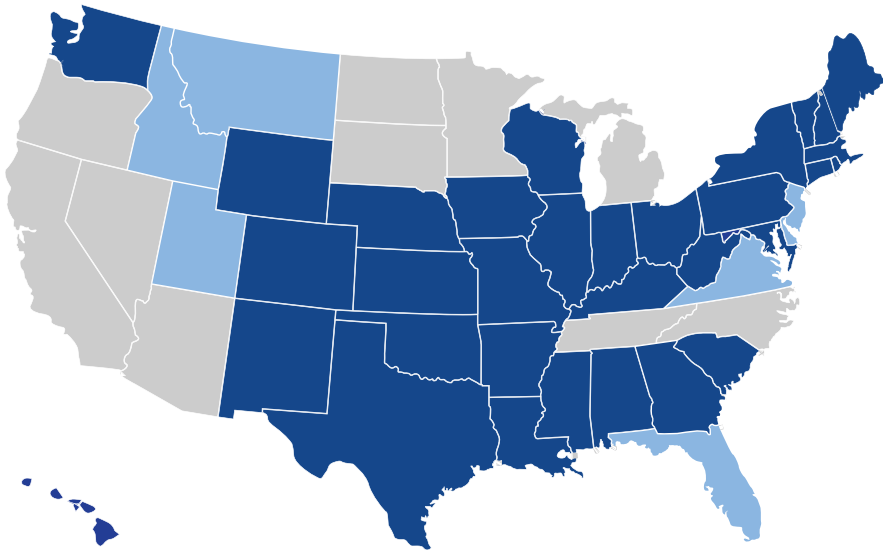

- Max 85% LTV on Purchase
- Minimum 600 FICO
- 1 to 4-unit properties
- Qualify solely off DSCR (No income docs)
- Condotels/Airbnb/Daily Rentals allowed
- LPC Available up to 3%
- No NMLS license required to originate in many States (see below)

IF:

- Borrower is a natural person
- Loan is secured by residential 1-4 dwelling
